
Record Note of discussion on Agenda Items of CSBFC

1 Approval of Adhoc Allotment of funds for the year 2010-11

CSBFC has approved Adhoc Allotment of funds for the year 2010-11, to all the Division/Units including funds for "Opening of Hostels" each at CDG & LKO, "Opening of Creches" each at UMB & MB & "Holiday Homes at Haridwar" already circulated vide letter No. 961E/117/CSBFC/2010-11/E-VI Dated 14.06.2010.

2 Implementation of various Welfare Schemes

- i) CSBFC members have decided to monitor the effective implementation of the schemes as mentioned in the CPO/IR's D.O.letter dated June,2010 to all DRMs/CWMs.
 - (A) Computer Education
 - (B) Scholarship for higher education to girl children of staff in grade pay Rs. 1800/- & below @ Rs. 1200/- P.M. (PS No. 13628/09)
 - (C) Scholarship for higher education of male children of staff in grade pay Rs. 1800/- & below. (PS No. 13696/10)
 - (D) Career Counselling & Training for developing occupational skills of Physically/Mentally Challenged Railway Employees & family members through SBF.
- 2 (ii) Further, it was decided to give wide publicity regarding various welfare schemes/activities available for wards of employees or family members through SBF, a colorful attractive posters be prepared and published on Northern Railway.



- 2(iii) It was agreed to allot an additional fund of Rs. 2,10,000/- as demanded by the CWM/AMV-LKO to impart computer training/education to Railway employees and their family members from the available funds of previous year 2009-10.
- 3 **Computer Education centers - Railway High School Bareilly**
It has been decided that Sh. S.K. Rana, AGS/NRMU & Member CSBFC along with Secy./CSBFC may inspect the Rly. High School Bareilly and analyse the computer training being given through Agency to students and submit report, so that continuance of the same be considered or discontinued.
- 4 **Women empowerment activities including higher education for girls.**
The proposal received from Dy.CMM/AMV-LKO to arrange "Women Kavya Samoroh" on the subject of women empowerment is approved by CSBFC and expenditure approx. Rs. 20,000/- will be arranged from the already allotted funds to Dy.CMM/AMV-LKO.
- 5 **Indigenous System of Medicine including Homeopathy/Ayurvedic**
CSBFC has approved a proposal for opening of one part time Ayurvedic Dispensary at Divisional Hospital, Moradabad on 4 hours daily basis in addition to one Ayurvedic dispensary is already being run for part time 4 hrs. daily at Harthala Railway Colony, Moradabad.
- 6 **Organization of Northern Railway employees camp by CSBFC**
i) CSBFC have decided to hold a Camp exclusively for female Railway employees of Northern Railway.
ii) CSBFC have decided to hold a second Camp for physically challenged employees of Northern Railway at Mount Abu.
- 7 **Workshop for Physically challenged employees of Northern Railway.**
i) CSBFC has approved a one day Workshop for Physically challenged employees of Northern Railway on the subject to 'Know about concession/facilities and provisions under rules'.
ii) Further, it was agreed to generate data/detailed position of Physically challenged employees and physically challenged wards of railway employees on Northern Railway. List of the same be prepared Division-wise/Unit-wise and same be discussed in the next meeting.
